
Description of this fund

The Fund is a portfolio, managed in pound sterling, with an exposure to 60% international equities and 40% international fixed Interest. The investment objective is to achieve income and/or capital returns through exposure to diversified assets and seeks to achieve its investment objective by investing primarily through passive, index-tracking investment funds managed by the underlying investment manager or associated investment managers that themselves seek investment returns corresponding to their own respective underlying indexes. The Fund is 100% invested in the Vanguard LifeStrategy 60% Equity Fund - Income (GBP) (Underlying Fund).

What are the risks of investing?

Risk indicator for the IVCM Vanguard LifeStrategy 60% Equity Fund


Example of how this applies to an investor¹

Ben had £10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of £118 (that is 1.18% of his initial £10,000). Ben also paid £0.00 in other charges. This gives Ben a total return after tax of £118 for the period.
