

**IVCM (NZ) PIE SUPERANNUATION FUND MEMBER TRANSFER OUT FORM**

Please read this form carefully and complete Sections 1 & 2 (Personal Information and Member Declaration), and have Sections 3 & 4 (Receiving Scheme Information and Payment Details) completed by the receiving scheme.

Along with the completed transfer discharge form, we request that you and the receiving scheme provide the following documentation.

1. Certified proof of identification¹ – certified copy of one form of the following photographic identification:
 - Current Passport
 - National Identity Card
2. Certified proof of residential address¹ – For example, a utility bill which should not be more than 3 months old.
3. HMRC letter/registration letter from the receiving scheme – This is a letter from the HMRC or the relevant registration authority to the receiving scheme manager stating that the receiving scheme is a valid and registered scheme, is on the QROPS list and has notified HMRC that they meet the criteria to become a QROPS.
4. Receiving Scheme Manager's License – A copy of the scheme manager's license to confirm that they are regulated by the relevant regulatory authority of the country in which the scheme is registered.
5. HMRC APSS255 Form – A completed HMRC APSS255 form, if you are transferring to another QROPS scheme. Page 1 and 3 to be completed by yourself and page 2 is to be completed by the receiving scheme.
