What is the purpose of this update?

This document tells you how the IVCM Vanguard Conservative Index Fund (**Fund**) has performed and what fees were charged. The document will help you to compare the Fund with other funds. Ranfurly Strategic Limited (**Ranfurly**) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this Fund

Australian dollars denominated fund employing a passive management strategy invested 30% in growth assets (International equities) and 70% in income assets (international fixed interest and cash and cash equivalents). The Fund’s investment objective seeks to track a composite index (before annual fund charge and tax), comprising 12% S&P/ASX 300 (AUD), 18% MSCI World ex-Australia net dividends (AUD), 60% Bloomberg Barclays Global Aggregate Float Adjusted Index and 10% Bloomberg AusBond Bank Bill Index.

What are the risks of investing?

Risk indicator for the IVCM Vanguard Conservative Index Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund’s assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

How has the Fund performed?¹

The market index annual return for the Fund is a composite index, calculated using 12% S&P/ASX 300 (AUD), 18% MSCI World ex-Australia net dividends (AUD), 60% Bloomberg Barclays Global Aggregate Float Adjusted Index and 10% Bloomberg AusBond Bank Bill Index. To the extent that imputation credits are available, they are included in the market index.

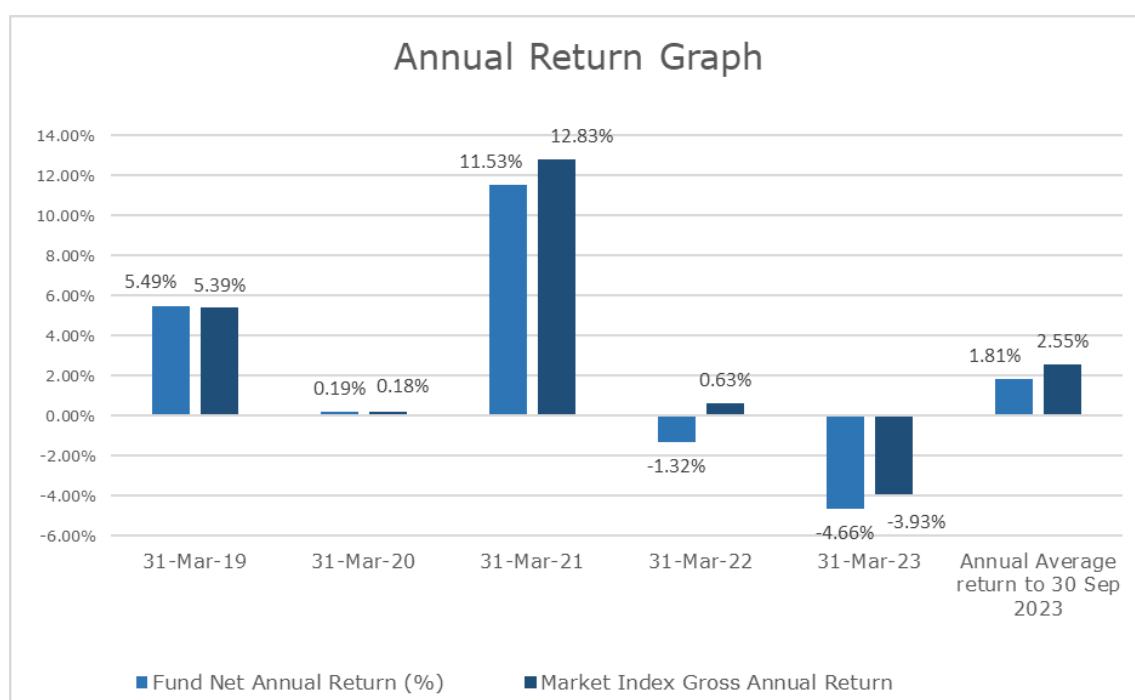
The market index changed on 21 December 2018 from a composite index, calculated using 12% S&P/ASX300 Index, 18% MSCI World ex-Australia Index (with net dividends reinvested) in Australian dollars, 60% Bloomberg Barclays Global Aggregate Float Adjusted Index hedged into Australian dollars and 10% Bloomberg AusBond Bank Bill Index to a composite index, calculated using 12% S&P/ASX 300 (AUD), 18% MSCI World ex-Australia net dividends (AUD), 60% Bloomberg Barclays Global Aggregate Float Adjusted Index and 10% Bloomberg AusBond Bank Bill Index as it is more appropriate index in terms of assessing movements in the market in relation to the returns from the assets in which the Fund invests.

Small differences in fees and charges can have a big impact on your investment over the long term.

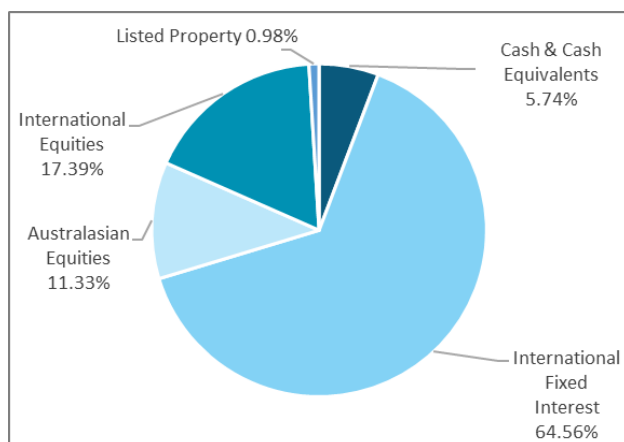
Example of how this applies to an investor

Ben had AUD \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of AUD \$505 (that is 5.05% of his initial AUD \$10,000). Ben also paid AUD \$0.00 in other charges. This gives Ben a total return after tax of AUD \$361 for the period.

What does the Fund invest in?

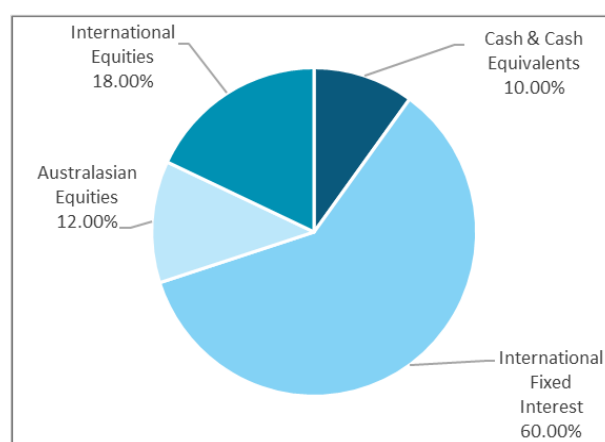
Actual investment mix

Currency hedging

The base currency of the Fund and Underlying Fund is Australian dollars. No currency hedging is performed at the Fund level and the Fund is not hedged to New Zealand dollars. Two of the investment funds that the underlying fund invest in are hedged back to Australian dollars by the investment manager of the Underlying Fund. The remainder of the investment funds that the Underlying Fund are invested in are Australian dollar denominated investment funds or investment funds that are not hedged. The two investment funds that the Underlying Fund invests in that are hedged are:

Ranfurly has made reasonable endeavours to obtain all relevant information regarding currency hedging, but due to a lack of information (i.e. the underlying investment manager does not publish foreign hedging levels) Ranfurly is not able to report the foreign hedging level of the two investment funds the Underlying Fund invests in.
